										<p>On today's date (05.05.2023) Deputy Commissioner of Public Safety JASON TETU came to HQ to make a formal report of a harassment incident that occurred yesterday. I witnessed a portion of the incident at the time that it occurred, so I assigned this report to myself.</p> <p>On 05.04.2023 at approx. 1330 hours I was on the first floor of City Hall, 474 Broadway, Saratoga Springs. I was at the end of the main corridor by DPW when I heard loud banging noises and someone shouting " you!" I activated my body camera and approached the person who was shouting at which time I observed a person known to me as RONALD KIM, the Mayor of the City of Saratoga Springs, NY standing in front of the office of the Commissioner of Public Safety. Kim then said, " you!" again and began walking towards the Mayor's office. I saw Tetu lean out of his office doorway and begin to speak to Kim. to Tetu, "You know that they're threatening my family and you don't do [redacted]? [redacted] off.. [redacted] you! Who are you, you [redacted]ing lazy piece of [redacted]!" Around this time Commissioner of Public Safety JAMES MONTAGNINO appeared in the doorway of his office and asked, "What's going on out here?" Mayor Kim answered Montagnino's question by advising Montagnino, "Go [redacted] yourself." Kim reiterated that someone was threatening his family. Tetu advised Kim that he was directed to report the incident to the Police Department but Kim did not go to make the report. Kim responded, "That's all I get? [redacted] you guys." Kim then entered his office while Montagnino and Tetu returned to their office. I then proceeded to my meeting.

On today's date Tetu advised me that Kim sent an email to Chief Crooks on 05.01.2023 reporting that he was threatened in an email that he was simultaneously forwarding to the Chief. The Chief advised Kim in a response email to come to the Police Department window to file a report. [redacted]

[redacted] I became aware that Kim did finally make a formal report about the threatening email after I saw him shouting in the hallway (see case SS-01160-23 for further). Tetu reported the details of the part of the interactions just prior to my arrival in the hallway. At approx. 1330 hours on 05.04.2023 Tetu was in his office when someone began aggressively pounding on the door to his office. Tetu opened the door with his arm and foot braced behind it because he was not yet aware who was banging on the door or what they wanted. Tetu said when he opened the door a small amount, Kim was standing there and began yelling at him and trying to push past Tetu by pushing against the door and reaching through the threshold of the door towards Tetu. Tetu was able to close the door and at this time I came into the hallway to witness the rest of the incident. Tetu further advised that Kim called Montagnino's office phone and had a conversation with Montagnino which was recorded in part. I am attaching the email chain referenced above to this case report for reference. Body camera and City Hall camera footage exist for this incident and have been saved for reference.

Tetu has declined to pursue charges against Mayor Kim at this time and only wished that I document the incident.
